Enjoy reading another exciting issue of our GSBM!



This is how the Saudi Minister of Transportation and Logistics Services H.E. Eng. Saleh Al-Jasser describes the Saudi goal for the logistics sector – mainly accomplished through massive investment in new technologies. The Saudi government is planning to invest more than SAR 1 trillion (USD 267 billion) in its logistics sector.

As H.E. Eng. Saleh Al-Jasser announced in his speech at the Global Logistics Forum on October 13, 2024, SAR 200 billion of the total amount already has been deployed. The investments will primarily be used to improve the Kingdom's infrastructure.

LOGISTICS SECTOR TO BOOST GROSS DOMESTIC PRODUCT

Approved by H.E. Crown Prince Mohammed bin Salman in mid-2021, the National Transport and Logistics Strategy aims to increase the transport and logistics sector's contribution to Saudi Arabia's gross domestic product from 6 percent to 10 percent.

This growth is projected to generate an additional \$12 billion in revenue outside the oil industry by 2030. The development of the logistics sector is already yielding positive results in 2024. In the second quarter of the year, the sector experienced the highest growth among the ten most promising industries in the Kingdom. Active business registrations rose to 11,928, reflecting a 76% increase from the previous year's 6,742 registrations.

FIRST SPECIAL LOGISTICS ZONE OPENED

A key aspect of the National Transport and Logistics Strategy is the creation of 59 logistics zones across Saudi Arabia to help establish the Kingdom as a global trade hub. Currently, the country has 22 logistics zones. The minister also noted that expanding ports and airports will enhance the flexibility of Saudi Arabia's logistics sector. On October 31, 2022, the first integrated special logistics zone was launched in Riyadh.

The Integrated Logistics Bonded Zone (ILBZ), developed by the General Authority of Civil Aviation (GACA), is situated at King Khalid International Airport in Riyadh.

Companies that meet the necessary criteria are granted exemptions from corporate tax and VAT for up to 50 years, along with relief from withholding tax on certain payments related to specific non-resident activities.

ESTABLISHMENT OF

59 LOGISTICS ZONES

CURRENTLY, SAUDI ARABIA HAS 22 LOGISTICS ZONES













The ILBZ is designed for companies engaged in logistics services such as maintenance, storage, import/export, value-added services, and recycling.

Firms in the zone can be fully foreign-owned, with no restrictions on capital repatriation. Imported goods entering the zone are free from customs duties and import restrictions. The General Authority for Zakat and Taxation issued the guidelines for companies wishing to establish operations in the zone, which were published in December 2023.

SAUDI LAND BRIDGE TO CREATE A LINK BETWEEN THE WEST AND EAST COASTS



One project that has been on the agenda for a long time but has not yet been implemented is the Saudi Landbridge Project. The Saudi Land Bridge project, a 950 km stretch from Riyadh to Jeddah, is to create a link between the ports on the Red Sea and the Gulf for the first time.

Construction work, which could take up to seven years, is due to start at the beginning of 2025.

The expansion of the rail network is intended to connect the deep-sea ports of Yanbu, King

Abdullah Port and Jeddah Islamic Port on the west coast with the industrial port of Dammam in the eastern province.

When completed, the Landbridge should be able to transport up to 50 million tons of goods per year.

AIR FREIGHT CAPACITY TO BE EXPANDED TO 4.5 MILLION TONS BY 2030



Before the coronavirus pandemic, air freight volume was 0.65 million tons (compared to 0.38 million in 2020), and it rebounded to 0.65 million tons in 2021. In 2023, capacity reached 0.92 million tons, with a target of 4.5 million tons by 2030.

In 2020, Saudi Arabian Logistics (SAL), the logistics division of SAUDIA Airlines, began operations at the Model Cargo Village at Riyadh King Khalid International Airport. According to GACA, the village has a capacity of 500,000 tons, with plans to reach 1.6 million tons annually once fully operational, covering an area of 350,000 square meters.

Additionally, a new terminal was added to King Abdulaziz International Airport in Jeddah in 2021.













The first phase of the terminal expansion spans 40,000 square meters and will handle inbound and outbound shipments, medical and refrigerated food shipments, high-value goods, dangerous goods, and transit shipments. The terminal is expected to increase annual capacity to 1.4 million tons.

CONTAINER CAPACITIES TO MORE THAN DOUBLE



So far, only a small portion of sea freight in Saudi Arabia has been attributed to international transit trade. The government aims to change this in the coming years. By 2030, container capacity is set to increase to 40 million TEU. From 2017 to 2023, a 55% growth has already been recorded, with container throughput reaching 20 million TEU.

King Abdullah Port is on track to become the country's largest container port, with an annual capacity of 25 million TEU planned. The port began operations in 2014 with a capacity of 2 million TEU and is now expected to handle over 5 million TEU. Since its opening in mid-2022, the port has processed a total of 15 million TEU.

STEADY EXPANSION AND AMBITIOUS GOALS OFFER GREAT POTENTIAL

Saudi Arabia has established itself as a prominent logistics hub, becoming increasingly appealing to international companies due to strategic infrastructure advancements and technological innovations.

However, the rapid growth also presents challenges in the logistics sector. One significant hurdle is the need to find skilled personnel and provide training for new staff, which could potentially hinder growth.

Despite this, the country's logistics sector will continue to benefit from Vision 2030 and the large-scale projects it entails, as well as from major events like EXPO2030, the 2029 Asian Winter Games, and the potential FIFA World Cup in 2034. As a result, the logistics sector offers diverse opportunities for German companies, alongside enhanced infrastructure for all businesses operating in or looking to enter the market.

Actual Challenges of Supply Chains

A reflection by Dr. Osama Alotaik, King Saud University Riyadh & Prof. Gerald Lang, Kedge Business School Paris

The Supply Chain is being transformed by digitalization through the collection, use and sharing of data: how is this evolution taking place?

There's a lot to say about digitizing the Supply Chain. First of all, let's be clear: digitizing the Supply Chain doesn't mean managing it with spreadsheets like Excel or others! Today, digitization means using management software (ERP or specialized Supply Chain software such as WMS, TMS, APS...) which collects and uses data to manage the Supply Chain. The first step is therefore to digitize the processes before digitizing the Supply Chain management itself.

One of the major objectives of the Supply Chain today is to synchronize the various players (suppliers, manufacturers, distributors, 3PLs etc.). To achieve this, systems must be able to exchange data on products or goods, inventories, transport and forecasts of the consumption. This often begins with sales forecasts. These can be based on predictive models using AI, which then determine planning and flow management processes.

By automating planning and flow management, a "control tower" can be set up to oversee the end-to-end Supply Chain, from suppliers to end customers. A malfunction, such as the breakage of a component or a critical out-of-stock situation, can be detected and automatically resolved if the part is shipped from a location where it is available. This automates decisions in the Supply Chain.

SAUDI ARABIA'S NATIONAL TRANSPORT & LOGISTICS STRATEGY

Saudi Arabia's Vision 2030 framework, through its National Transport and Logistics Strategy (NTLS), emphasizes digitalization and advanced logistics solutions to enhance the country's global standing in logistics and transportation.

NTLS aims to create a digital ecosystem to improve air, sea, and land transport capacity, thereby streamlining global trade connections. NTLS is not only a vision of how the future should look like; it has executable programs and initiatives that shows a clear pathway of how to get to Vision 2030 goals. Some of these initiatives already achieved outstanding outcomes. For example, the efficiency of port operations, which is crucial for trans-shipment operations, has significantly improved. This achievement is the result of numerous efforts such as regulatory reforms but also a result of operational excellence through digitalization.

Other aspects of NTLS have not yet reached its goals. These aspects present promising opportunities. For example, one of the objectives of NTLS is the provision of smart solutions to transport challenges through the adoption of cutting-edge and innovative emerging technologies. Adopting innovative technologies such as the Internet of Things (IoT) will facilitate digitalization by enhancing end-to-end real time visibility of the Supply Chain.

Saudi Ports Authority (Mawani) has collaborated with IBM to launch an online learning and innovation platform to learn about developments, emerging technologies and trends prevailing in the digital world, which will contribute to accelerating the pace of digital transformation in the port sector.

The Supply Chain is faced with the imperative of sustainability & decarbonization to meet carbon neutrality targets by 2050. What answers can it provide?

The reduction of greenhouse gases (GHG), of which CO2 accounts for around 75%, is a priority for the Supply Chain, and more particularly for logistics. Saudi Arabia's logistics strategy highlights sustainability as a core pillar. One of its objectives is reducing fuel consumption by 25%.

The biggest emitters of GHGs in the Supply Chain are transport activities, due to the internal combustion engines of trucks and freight ships.



The first line of action is to reduce the number of kilometers covered, to consume less fuel. This can be achieved by optimizing collection and/or delivery routes by the use of AI and machine learning-based tools.



The second area of work involves optimizing truck loads to reduce the number of rides made partially empty. Some studies indicate that 25% of truck capacity is unused while on the road.

The other positive effect is that, from an economic point of view, optimizing routes and loads also reduces transport costs for companies. This proves that reducing environmental impact can often also reduce operational costs.

It's worth remembering, however, that the truck remains irreplaceable in many situations, especially over short distances: it provides access to virtually every place where there is a road, unlike more environmentally friendly modes of transport, such as boats or trains, which don't offer the same flexibility or speed in terms of delivery.

While the truck remains irreplaceable, there are other ways of reducing the carbon footprint: using trucks with greater capacity, training drivers in eco-responsible driving or using biofuels where possible.

Another lever is the sourcing of materials and products required for business activities. If this is organized in such a way as to give priority to geographical proximity, substantial savings can be made. This calls for optimized design of the Supply Chain network. Finally, the organization and efficiency of return flows also influences on environmental impact and GHG emissions.

All the above are examples of operational, tactical, or strategic actions at companies' disposal to deal with sustainability challenges in the Supply Chain. In Saudi Arabia, there is opportunity in building the infrastructure that enables the above-mentioned actions. Under Vision 2030, initiatives like expanding the national rail network are designed to reduce the carbon footprint by offering more sustainable freight transport options. The country is also investing in eco-friendly infrastructure and encouraging clean energy alternatives in logistics to align with its long-term goals of reducing emissions

What economic resilience can we expect from the Supply Chains?

Current risks, such as geopolitical instability and rising energy costs, are pushing companies to rethink Supply Chains for greater resilience. Many businesses are nearshoring or backshoring manufacturing and increasing geographically distributed storage to manage risks more effectively.

Saudi Arabia's strategy reflects this focus on resilience through its expansion of logistics infrastructure. By enhancing road, rail, and sea connectivity, the country aims to support global trade flows even during disruptions. This approach not only strengthens the national economy but also builds a more resilient Supply Chain by diversifying transportation modes and improving network flexibility.

By establishing hubs where our customers can request and access parts directly, we ensure the right parts are available at the right time." We are involved in nearly all types of mega projects in the Kingdom. Due to our diverse range of products and our reliability in quality and service, our equipment is in demand for these large-scale projects.

We see German companies committing to Localization in KSA. Liebherr has already shown a strong commitment. Can you tell us about your efforts.

We started our commitment in the 80s, when the visionary Mr. Hans Liebherr saw the potential in this country. Our commitment to this country remains as strong as before, even though we are currently facing challenges due to competition from the Far East. Our commitment will even be expanded, as we are planning a new production facility for transit mixers in KAEC, a new head office, warehousing and service center in Jeddah, and upgrading our service and spare parts center in Riyadh to state-of-the-art standards.

The Aviation Industry in KSA

MARKET DEVELOPMENT FOR GERMAN COMPANIES

Driven by Vision 2030, Saudi Arabia is currently undergoing a transformation and diversification in economic, social and cultural terms.

CURRENT MARKET DEVELOPMENTS

The aviation industry is also integrated into Vision 2030 through the so-called "Saudi Aviation Strategy" and is to be significantly transformed. The Kingdom of Saudi Arabia has committed to investing \$100 billion in the restructuring and expansion of the Saudi aviation industry. The General Authority for Civil Aviation (GACA) is the regulator responsible for this in Saudi Arabia.

The Saudi aviation strategy aims to achieve the goals of the national tourism strategy (330 million passengers) and to meet the national air freight requirements (2.5 million tons). In addition, Saudi Arabia is to be developed into a global transit hub (30 million passengers) and a global air cargo hub (2.0 million tons of transit). The aim is to develop the aviation sector in Saudi Arabia into the leading aviation sector in the Middle East.

EXPANSION STRATEGY TO CONNECT INTERNATIONAL DESTINATIONS FROM 29 SAUDI AIRPORTS IN SAUDI ARABIA

EXPANSION OF CONNECTIVITY

Other pillars of the aviation strategy include the expansion of connectivity from 29 Saudi airports in Saudi Arabia to over 250 international destinations. The airports in Riyadh (RUH) and Jeddah (JED) are to act as global long-haul and air cargo hubs in the future.

Furthermore, the competitiveness of local airlines is to be increased and two new airlines, Riyadh Air and NEOM Air, are to be introduced to the market. With Saudia, flynas, flyadeal, Riyadh Air and NEOM Air, Saudi Arabia will have five local airlines in 2025.

With an expected number of 150 million tourists per year, including 30 million Umrah and 7 million Hajj (Muslim pilgrimage) tourists, the need for new airlines is increasing. A comprehensive expansion and improvement of the airport infrastructure is also being sought.

ADVANCED AIR MOBILITY

Furthermore, Saudi Arabia is increasingly focusing on advanced air mobility. Here, the "Advanced Air Mobility Strategy" concentrates primarily on the core areas of passenger transportation, freight transport and utility services, particularly in the sectors of area mapping, agriculture, advertising and entertainment, infrastructure and construction site inspections, security applications and firefighting. By 2040, the Saudi government plans to contribute several billion US dollars to GDP and create thousands of jobs.

BECOMING A GLOBAL HUB

There are currently a large number of projects in the Saudi aviation industry. In order to function as a global hub with optimal international connectivity in the long term, Riyadh Airport is currently undergoing a fundamental restructuring with extensive new construction measures. The new master plan for King Salman International Airport covers an area of 57 square kilometers and will expand and replace the existing King Khalid International Airport in Riyadh. The airport is set to become one of the largest airports in the world with an annual volume of 120 million passengers. The airport is expected to contribute SAR 27 billion (\$7.18 billion) annually to Saudi Arabia's gross domestic product (in the non-oil sector).

Traditionally busy with pilgrimages to the holy sites of Mecca and Medina, the airport in Jeddah has already built its own Hajj terminal and is constantly working to expand capacity and optimize passenger flow at the airport. Some projects such as the construction of Jubail Airport, Amaal Airport and the two airports located in NEOM (NEOM Bay Airport and NEOM International Airport) are already at an advanced stage of planning. Furthermore, the development of Taif, Hail and Al Qunfudah airports are in an early planning phase.

POTENTIAL FOR GERMAN COMPANIES

The Saudi aviation industry offers great potential for German companies. From large global players to innovative niche providers and SMEs looking for partnerships, there are a variety of opportunities for cooperation.

Some global players have recently benefited from the current expansion. Frankfurt airport operator Fraport, for example, plays a key role in the transformation of the aviation industry and has established itself as a strategic partner. There is also a long-standing partnership between Airbus and the Saudi airlines, which is being intensified by the transformation.

German companies also have numerous opportunities to contribute their expertise and know-how to the development and expansion of the airports. German technology solutions are already in place in the areas of baggage handling, logistics and passenger management. For example, the German company Beltcon supplies baggage conveyor belts for various airports in Saudi Arabia via its local partner MAFA.

Advanced air mobility also offers opportunities. There is a willingness in Saudi Arabia to invest in new technologies and to promote new forms of mobility.

German technologies in this area are in high demand and have a good chance of establishing themselves on the Saudi market. Overall, German companies are in a position to play a central role in the ongoing transformation of Saudi Arabia by contributing expertise, innovation and value creation, thus creating mutually beneficial partnerships.

We see immense potential in Saudi Arabia. The mega projects alone - the construction of King Salman Airport in Riyadh and the expansion of the airport in Jeddah - offer fantastic opportunities. In addition, there is the construction of smaller airports such as NEOM and Alula. Saudi Arabia wants to handle 330 million passengers per year by 2030. A huge amount of technology and know-how will be needed to achieve this.

German companies can also benefit here - if they do their homework. Companies need to take a close look at the market and get involved in it - without a certain focus on the market, it will be rather difficult. But one can say: due to the large number of projects in this tight time frame, the Saudi market is certainly one of the most interesting markets in the coming years.

After visiting the Kingdom with aviation companies twice, where do you see the biggest hurdles in doing business?



Kevin Fischer

Certainly, a lack of knowledge and unfamiliarity with the market. In addition, Entrepreneurs utilize the visits whether the investment and commitment to the country is worthwhile for them. Especially the localization trend for SME companies something to be scrutinized in detail.

German companies need to find their competitive edge and niche, as we observe a strong competition from far east.

We see the importance in finding the right local partner It becomes particularly difficult if you don't have the right local support - so it's good that GESALO is on hand to help our companies in entering the market.

SAUDI AVIATION SECTOR VAST OPPORTUNITIES FOR GERMAN TECHNOLOGY PROVIDED IN KSA

THE BOOMING F&B SECTOR IN SAUDI ARABIA – A SECTOR ON THE RISE





The food market in Saudi Arabia is changing rapidly. Current developments towards organic products, dietary products and healthy eating are on the rise.

With a growing, young population with an average age of 30.6 years, consumer behavior in the food sector is rapidly changing, demanding new products and fresh trends. Saudi Arabia's food importers are adapting to these demands and are focusing on several products that are expected to do very well in the next period: processed meat, seafood, ready-made meals, baby food, ice cream, breakfast cereals, processed fruits and vegetables, beverages. The fast-growing segment of restaurants which are in between Michelin-star locations and fast-food places also drives the import of high-quality, gourmet food ingredients.

A delegation with German manufacturers from the food sector, organized by GEFA Exportservice GmbH, in cooperation with the Delegation of German Industry & Commerce for Saudi Arabia, Bahrain and Yemen in Saudi Arabia and the German

Emirati Joint Council for Industry and Commerce United Arab Emirates (UAE) and the association Food - Made in Germany e. V., on behalf of the Federal Ministry of Food and Agriculture (BMEL), granted the opportunity for first-hand exploration of the Saudi food market and the establishment of contacts therein.

Following a briefing at the GESALO headquarters by Dr. Dalia Samra-Rohte, Delegate of German Industry & Commerce for Saudi Arabia, Bahrain, and Yemen, providing an overview over the current market situation, a visit to the Ministry of Investment (MISA) gave insights into particularly financial questions.

Ensuing store checks at different Saudi supermarkets granted the opportunity for on-the-spot exploration and offered direct insights into the product ranges of respective market chains, as well as potential market niches.





During B2B talks with established players in the Saudi food sector, prospective business opportunities and existent market potentials could be explored. This gave room for exchange with interesting partners establishing first contacts and for networking with potential future partners. Notably, WIKA and AUMA have established regional headquarters in the Kingdom, demonstrating the strength of this collaboration.







How has the competitive position of your company changed at your location in the last 5 years?



How do you judge the local economic development in the next twelve months?









In a significant milestone for the petrochemical industry, in April BASF, SABIC, and Linde inaugurated the world's first large-scale electrically heated steam cracking furnaces at BASF's Verbund site in Ludwigshafen.

Since then, the demonstration plant has been in operation. This groundbreaking facility is a lighthouse project, marking the dawn of a new era where electricity could replace in the long term conventional fuels in steam cracking—a process essential for producing vital chemicals like olefins..



REPLACEING THE CONVENTIONAL USE OF NATURAL GAS

The innovative technology powering the demonstration plant seeks to replace the conventional use of natural gas with electricity derived from renewable sources, highlighting the industry's commitment to sustainability. The two electrically heated furnaces together process around 4 tons of hydrocarbon feedstock per hour and consume 6 megawatts of renewable energy. Our demonstration plant is the culmination of three years of meticulous collaboration and innovation among the three industrial giants

BASF and SABIC have extensive know-how and intellectual property in developing chemical and petrochemical processes as well as longstanding experiences and knowledge in operating steam crackers.

Both companies have holistic programs in place to address emission reductions. Linde, as Engineering, Procurement & Construction (EPC) partner contributes with its intellectual property, its expertise in building and developing steam cracking furnace technologies as well as driving future commercialization for process engineering systems and technical development.

SABIC's role in the electric furnace project supports Saudi Vision 2030's focus on diversifying the economy and fostering innovation and sustainability. This reflects Saudi Arabia's dedication to advancing sustainable technologies within the global chemical sector.



REVOLUTIONIZEING STEAM CRACKERS METHOD

Traditionally, steam crackers require immense energy to break down hydrocarbons, achieving temperatures of up to 850 degrees Celsius through fossil fuel combustion. This process has been a major contributor to greenhouse gas emissions. However, the new electrically driven furnace aspires to revolutionize this method, significantly curtailing emissions associated with one of the industry's most energy-intensive processes.

Fully integrated into the existing infrastructure at Ludwigshafen, the plant is poised to enrich the scientific community with valuable data on material behavior under commercial conditions.



It features two distinct demonstration furnaces exploring different heating methods: direct heating, which allows electric currents to flow through cracking coils, and indirect heating, which uses radiative heat from surrounding elements. Together, these methods process approximately 4 tons of hydrocarbon feedstock per hour, underscoring the plant's substantial contribution to decarbonization.

SIGNIFICANT BOOST FUNDING UNDERSCORES GERMANY'S COMMITMENT

This innovation received a significant boost from the German Federal Ministry for Economic Affairs and Climate Action, which granted €14.8 million to support this groundbreaking initiative. This funding underscores Germany's commitment to aiding energy-intensive enterprises in their quest for carbon neutrality. BASF, SABIC, and Linde have not only laid the groundwork for technological advancement but also illuminated a path toward a more sustainable, climate-neutral future for the global chemical industry. Through their collective vision and determination, they have redefined what is possible, inspiring the industry to envision a world where sustainability and productivity coexist harmoniously.

Landmark Reform of KSA Labor Law

The KSA Council of Ministers has passed a transformative labor law reform with innovations designed to foster a more inclusive and high-performance work environment for employees and employers alike.

EMPLOYER-PAID MATERNITY LEAVE

Amongst the most significant key amendments is the extension of employer-paid maternity leave, which now increases from 10 to 12 weeks, with six weeks required post-delivery – bereavement leave has also been increased to provide three days of paid leave for employees mourning the loss of a sibling, in a solicitous step ahead towards strengthening kinship ties.

RESIGNATION PROTOCOLS ON FIXED-TERM CONTRACTS

The reforms also shed light on resignation protocols, particularly for non-Saudi employees in regard to fixed-term contracts as they can now resign with a 30-day notice.

Employers, however, can delay acceptance of resignation by up to 60 days if operationally necessary, provided they notify the employee in writing with justification.

The notice period for indefinite-term contracts for Saudi nationals has also been reduced, requiring only 30 days' notice from employees for voluntary termination, though the employer remains obliged to provide a 60-day notice for terminations.

PROMOTING WORK-LIFE INTEGRATION

The amendments bring clarity to the adaptability in overtime arrangements, permitting employers, with employee consent, to offer paid leave in lieu of overtime compensation, promoting work-life integration. The probation period for new hires has also been extended, allowing employers to define up to 180 days of probation in employment contracts.

The reforms address essential living conditions as well. Employers are now mandated to provide either adequate housing and transportation or allowances to cover these needs, bolstering employee welfare and convenience.

A pivotal enactment is the prohibition of discrimination based on race, color, gender, disability, or age in recruitment practices.

REFORM COMES INTO FORCE

Set to come into force 180 days after its publication in the Official Gazette on 23/08/2024 – in a sweeping reform to underscore Saudi Arabia's commitment to labor integrity and contribution to its ever-evolving workforce demands.

Liability For International Transport Damages in Saudi Arabia: A Legal Analysis

The international transport of goods is a central component of global trade and Saudi Arabia, as one of the largest economic centres in the Middle East, plays a significant role in this. As part of Vision 2030 and in line with the country's national transport and logistics strategy, the transport of goods is to be further diversified by 2030 and capacities by land, sea and air are to be massively expanded.

The country's main exports are oil, gas, petrochemical products and chemical products. The main imports are food, vehicles, machinery and electronics. In 2023, goods worth an estimated USD 211 billion were imported into Saudi Arabia. German direct investment in Saudi Arabia mainly takes place in energy and infrastructure projects.

International trade is usually associated with transport damages, which can lead to considerable financial losses for exporters and importers. Legal liability in such cases is often complex and can arise from numerous legal bases. This article is intended to provide an overview and shall highlight the most important issues in connection with international transport damages in Saudi Arabia.

I. INTERNATIONAL CONVENTIONS

Global trade is strongly characterised by international conventions, which provide a legal framework for the international transport of goods and can be used as a legal source for liability issues.

SEA TRANSPORT



The area of maritime transport is regulated by the International Maritime Organisation (IMO) and the International Convention for the Unification of Certain Rules relating to Bills of Lading (Hague Rules).

The latter contains provisions regarding liability in maritime transport. Among other things, a limitation of liability for carriers is provided for. This limitation is often a certain amount per unit of weight of the damaged goods, unless the shipper has declared a higher value of the cargo and recorded this in writing, or the transport damage is due to intent or gross negligence on the part of the carrier. The respective contracts should therefore take these regulations into account accordingly.

RAIL TRANSPORT



Regarding rail transport, the Convention concerning National Railway Traffic (COTIF) is central to this. The agreement applies in Europe, in some Maghreb states and in parts of the Middle East. Saudi Arabia is not yet a member of the agreement, which is also due to the fact that the country's railway infrastructure has not yet been fully developed. Saudi Arabia has published plans to triple the national rail network in 2022 by building more than 8,000 kilometers of track, which could make the issue more relevant in the future.

AIR TRANSPORT



When it comes to air transport, the so-called Conventions on International Air Transport (initially the 'Warsaw Convention', later replaced by the 'Montreal Convention') must be taken into account. The Montreal Convention regulates liability issues in international civil air transport and therefore also covers cargo transport in addition to passenger transport. Saudi Arabia is a party to this convention, which means that it applies to all relevant matters in this context. Specifically, the liability of the contractual air carrier for damage to persons, baggage or cargo is regulated. The convention introduces clear maximum liability limits and exemptions from liability, which must be taken into account when drawing up contracts for the transport of passengers or goods by air.

II. NATIONAL LEGISLATION

However, the most important point of reference for the question of liability in international transport is the respective national law. With the recently modernized Saudi Commercial Maritime Law, there is a special national legal basis for maritime trade in addition to the applicable international agreements. In addition to provisions on registration and rights in rem at sea, it also contains detailed regulations on maritime contracts, including the carriage of passengers and goods by sea under bills of lading.



In addition, road transport in particular, which still plays a fundamental role in global trade alongside other transport routes, has so far been largely subject to Saudi Arabia's national legislation. In this context, the Saudi Commercial Law and the Saudi Civil Code, which came into force at the end of 2023, are particularly relevant.

Both laws contain provisions that can be applied in connection with transport damages. They therefore form the primary basis for the legal assessment of claims for damages in Saudi Arabia. In addition, many regulations, e.g. the Regulation for Transport of Goods, Freight Forwarders and HGV Hire on Land Roads (Regulation for Transport of Goods), contain technical legal provisions on the transport of goods, which could be also considered as a breach of duty in contractual relationships and can therefore help determine liability issues.

Which regulations apply always depends on the structure of the respective contractual relationships in each individual case.

THE CONTRACT OF CARRIAGE

The contractual agreements between the shipper (importer or exporter) and the carrier generally form the basis for liability in the event of damage. The so-called duties of care of the carrier are particularly important here. It should be clearly and comprehensibly regulated in the contract to what extent the carrier must control and monitor the proper transport of goods and to what extent he is responsible for what damage. It is also important to keep an eye on the rights and obligations of subcontractors and transport assistants in order to be able to quickly and legally resolve constellations with several companies involved.

LIABILITY OF THE CARRIER

If the contract of carriage or freight contract does not contain any special provisions, Saudi Arabian law generally stipulates that a carrier is liable for damage to the transported goods if he does not transport them properly and safely. The decisive factor here is whether the damage was caused by the fault of the carrier or its vicarious agents. According to the new regulations of the Saudi Civil Code, a hypothetical calculation of damages is possible for breaches of contractual obligations, which now expressly includes loss of profit.

The Saudi Civil Code also contains the possibility of agreeing liquidated damages. This gives the parties the opportunity to map financial risks at the beginning of the contractual relationship - e.g. by means of staggered lump sums for certain scenarios - without the amount of the claim for damages having to be subsequently determined by a court. However, the court seised retains the right to adjust the damages upwards or downwards at its discretion if the situation so requires. In addition, the prohibition of interest (riba) in Saudi Arabia, which is based on Sharia law, also applies in connection with transport damage.

EXCLUSIONS AND LIMITATIONS OF LIABILITY


In order to limit the liability of the carrier or other companies involved, exclusions or limitations of liability are often contractually agreed between the parties.

From the carrier's point of view, it is advantageous to reduce its liability to a minimum or to be able to pass it on to other companies involved.

From the commissioning company's perspective, on the other hand, it should be ensured that the exclusions and limitations of liability are only moderate. Of course, this always depends on the respective negotiating position of the parties.

In this context, however, it should be noted that contractual clauses can be deemed invalid by Saudi courts if they unreasonably disadvantage one of the two parties or violate Sharia principles in the opinion of the court. In addition, limitations of liability can be cancelled if transport damage is due to gross negligence or willful misconduct on the part of the carrier.

In addition to contractual limitations, there are also statutory exclusions of liability that are directly enshrined in Saudi law. For example, a carrier can be exempted from liability if the damage was caused by external influences such as force majeure, acts of war or natural disasters. Another liability privilege relates to damage caused by inadequate packaging or insufficient labelling on the part of the shipper. Here too, the carrier's liability may be limited.



III. INTERNATIONAL COURT AND ARBITRATION PROCEEDINGS

In addition to the question of the carrier's liability, the extent to which clauses on applicable law and jurisdiction can be effectively agreed and then enforced is particularly important in the case of transport damage in international trade.

In principle, the Saudi Civil Code does not recognise any private international law or corresponding conflict of laws rules. Consequently, a Saudi court seised will generally always apply Saudi law and will not recognise a choice of law clause in an international contract. International law is only applied within the framework of the UN Convention on Contracts for the International Sale of Goods, which was recently also recognised in Saudi Arabia, and when arbitration clauses are agreed.

With regard to the enforcement of foreign judgements, there are still no bilateral agreements between Saudi Arabia and Germany or other European countries. The enforcement of such judgements is therefore still subject to extreme legal uncertainty. In contrast, foreign arbitration awards are increasingly being recognised by Saudi courts, even if Sharia law and a comprehensive ordre public reservation linked to it do not yet allow for a fully secure recognition practice.

Companies should therefore make absolutely sure that their freight is adequately insured, especially when transporting high-priced goods or goods with a high risk potential. As the injured company can assert claims in Saudi Arabia both directly against the carrier and against the insurer, it is advisable for the carrier to take out appropriate public liability insurance to protect itself against major financial risks.

CONCLUSION

Liability for transport damage requires a careful legal assessment based on the relevant international and national legal sources. Economic operators should always inform themselves about the applicable laws and regulations and - as far as legally possible - define clear liability provisions in their contracts. This not only helps to minimise financial losses, but also to avoid legal disputes in the event of damage.

Due to the rapid economic and legal developments in Saudi Arabia, it is to be expected that the handling of transport damage will continue to be a major topic in the legal practice of lawyers in the Middle East and in Saudi Arabia in particular. Companies should therefore familiarise themselves comprehensively with the relevant regulations and respective structuring options.

IV. INSURANCE TOPICS

Finally, a key aspect in dealing with transport damage is the role of the respective insurance company, which covers the insolvency and enforcement risk of any claims that may arise. In the best case scenario, appropriate insurance policies fully cover both national and international risks during the transport of goods.

Centralized and Electronic Commercial Register to Enter Into Force on March 30th 2025

A centralized electronic commercial register managed by the local Ministry of Commerce will enter into force on March 30, 2025. The new Commercial Register Act pursuant to Royal Decree No. (M/83) of 19.3.1446 AH and Resolution No. (237) of the Council of Ministers of 14.3.1446 AH modernizes the law of the previous registration procedure

The law renders registration mandatory for all companies. Further, it requires that any changes to existing registration data be updated in a timely manner and provides clear procedures for deletions. It also introduces a structured framework of sanctions for violations.

UNDER THE CURRENT LAW

- the registration requirement only applied to merchants with a capital of more than SAR 100,000.00. Accordingly, merchants had to register within 30 days of commencing business or reaching the defined capital limit;
- the paper-based system was based on physical documents, making access to information cumbersome leading to increased processing times;
- Changes were to be submitted via requests within 30 days, which often lead to delays in updating information, as the actual registration of the update in the register required additional time;
- Sanctions for non-compliance are fines, but these are generally not enforced.

KEY FEATURES OF THE NEW LAW:



- Universal registration requirement: all traders are required to register their business to ensure uniform compliance.
- Centralized electronic registration platform: an electronic system for submitting registration applications will be introduced, reducing processing time to just 10 days.
- Streamlined information requirements: Traders now only need to provide key data, such as trading name, legal form and capital
- Accelerated amendment procedures: Updates to registered data must be made within 15 days.
- Specific penalties for violations, higher fines (SAR 50,000.00) for repeated violations and provisions for issuing warnings before imposing fines.

How Saudi Arabia's New Laws Are Set to Redefine Product Safety

The Kingdom of Saudi Arabia is setting new standards in consumer protection. With the entry into force of the laws on product safety and standardization on November 16, 2024, a comprehensive new legal framework was introduced, which holds manufacturers and importers accountable. This is intended not only to increase the safety of products, but also to strengthen consumer confidence in the Saudi market.

A NEW COMPREHENSIVE LEGAL FRAMEWORK

The Kingdom of Saudi Arabia has enacted two significant legislative measures under Cabinet Decision No. 93/1446, creating a comprehensive legal framework for product safety and recall procedures. The Standards and Quality Law and the Product Safety Law, which came into force on November 16, 2024, are designed to regulate the responsibilities of manufacturers and importers while expanding the oversight capabilities of regulatory authorities.

STANDARDS AND QUALITY LAW

The Standards and Quality Law is intended to establish a general framework for standardization and quality control across Saudi Arabia. The law defines "quality" as the degree to which products meet specified requirements, consumer expectations, or regulatory goals.

It outlines the obligations of manufacturers and importers, appointing the Saudi Standards, Metrology, and Quality Organization (SASO) as the central authority responsible for overseeing all standardization and quality-related activities, except for those products regulated by the Saudi Food and Drug Authority (SFDA).

THE STANDARDS &
QUALITY LAW AND THE
PRODUCT SAFETY LAW



EFFECTIVE FROM

Nov 16, 2024

Under this law, SASO is vested with enhanced authority to monitor and enforce compliance with product standards. This includes the power to appoint inspectors authorized to conduct routine inspections and verify adherence to safety standards. The enactment of this legislation represents a pivotal step forward in consumer protection and reflects Saudi Arabia's commitment to improving market safety and regulatory enforcement.

PRODUCT SAFETY LAW

The Product Safety Law applies to all products, including those sold through online platforms, with the exception of items regulated by the SFDA. The primary objective of the law is to safeguard consumers from potential risks posed by unsafe products in the marketplace.

The law imposes stringent legal obligations on manufacturers, authorized representatives, and importers. These include ensuring that products meet all safety requirements, compiling a comprehensive technical dossier to demonstrate compliance, and issuing a declaration of conformity. Distributors are required to undertake due diligence to ensure that the products they offer comply with relevant legal and regulatory standards, and they are prohibited from selling noncompliant goods. The law further stipulates that manufacturers are liable for defects in their products, while importers assume liability for products manufactured outside the Kingdom.

PENALTIES FOR NON-COMPLIANCE

Violations of these laws are subject to severe penalties, including fines of up to ten million Saudi Riyals, closure of the company for up to one year, or imprisonment for up to ten years for deliberate violations. These penalties underscore the seriousness with which Saudi Arabia is addressing consumer protection and market regulation.

Overall, the new laws represent an important step towards more comprehensive consumer protection in Saudi Arabia. With the introduction of the new laws, manufacturers and retailers should prepare for the new requirements early and consult their legal advisors to ensure compliance.



The Eastern Province with the conurbation of Dammam, Dahran and Al Khobar is becoming increasingly interesting - for tourism, business and culture. This is the centre of the oil industry and ARAMCO is omnipresent - including spectacular cultural centres, museums and industrial parks.

INVESTING IN THE PRESERVATION OF NATIONAL IDENTITY

It is interesting to note that the giant oil company has been investing in culture, education and renewable energies, among other things, for many years. ARAMCO executives invest in the preservation of national identity through decades of collecting artefacts from the rich cultural heritage, creating private museums worth seeing as a reflection of culture, archaeology and history.

During my visit to Dammam/Dahran, two extraordinary private museums and 'Ithra' are on the programme.


ITHRA - KING ABDULAZIZ CENTRE FOR WORLD CULTURE

Opened in 2018, Ithra, an ARAMCO venture in Dahran, is still one of the biggest visitor attractions when it comes to architecture, art, history and culture. There is a huge library and the museums, theatre, cinema, congress hall and art gallery host sensational exhibitions and international conferences. The permanent exhibition on Islamic art is also outstanding.

Ithra has been awarding an art prize worth USD 100,000 for several years now,' explains my guide Mohammed.

One of the most important exhibitions to date was 'Hijrah: In the Footsteps of the Prophet' in 2022, which covered the Prophet Mohammad's eight-day journey from Mecca to Madinah. It traced the course of this journey for the first time and in an unprecedented and contemporary way, exploring its social, political and cultural impact on the world through an immersive multimedia show. Remarkably, the project involved more than 70 researchers, prominent scholars, international organisations and artists from over 20 countries around the world.

Laila Al-Faddagh, Director of the National Museum in Riyadh, said: 'Through these exhibitions, which are held in collaboration with other institutions such as Ithra, we at the National Museum aim to increase understanding of our culture, our history and the ancient and diverse civilisations that resided in our country.'



MOUNIRA MUSEUM

Our next destination is within sight of Ithra: the heavily guarded ARAMCO complex with a large number of private houses inhabited by ARAMCO executives and their families. We are checked at the barrier at the entrance to the complex but are allowed to pass quickly because we are registered at the 'Mounira Museum' and are expected there - in the home of Mounira Ashgar and her husband Saud Ashgar.



The special thing about their house is that it is both a home and a private museum and is used as such for special events. Mounira Ashgar welcomes us with great friendliness in the spacious, pillared reception hall. I discover traditional artefacts and handicrafts of the very best quality. These include mashrabia and paintings in gilded wooden frames as well as calligraphy on the walls. Several gigantic chandeliers and brass lamps hang from the ceiling; large porcelain and glass vessels are placed on the marble floor, as well as brass dallahs in various sizes. Beneath the glass of numerous wooden tables, traditional daggers, pistols, short swords and ammunition belts richly decorated with silver and gold are displayed alongside jewelry. Traditional Bedouin jewelry can be seen in a glass display case.

And finally, I find a traditional face mask that women wore before the introduction of the black abaya - ornately decorated with real silver coins and pearl embroidery. I am still engrossed in the fossils when Mr. and Mrs. Ashgar join me and invite me for tea and biscuits. They both talk about their many travels around the world and Mounira tells me about her special interest in traditional fashion. "You are welcome to see such dresses in the exhibition rooms of my museum on the first floor.' On the way up, antique wooden farming tools can be seen on small platforms. Once at the top, a large room opens up with many shelves and display cabinets filled to bursting with exhibits of Islamic art. The collection of traditional dresses from all regions of the Kingdom is sensational. Many of the garments are worn by life-size dolls.

What's your next destination?' asks Mounira Ashgar. She is delighted with my answer: 'It's a good thing you came to me first - when you get there, you'll know why!'

ALFELWAH AND ALJOWHARAH MUSEUM IN DAMMAM

Only half an hour's drive separates us from this private museum in Dammam and now I understand Mounira Ashgar's reaction.

Millionaire Abdulwahab Al Ghunaim, an avid collector of cultural and traditional artefacts, welcomes us into his huge, multi-storey, palatial building.

Al Ghunaim tells us: 'The museum is named after my two daughters. It was opened in 2017 and contains over half a million artefacts, making it the largest private museum not only in Saudi Arabia, but in the Middle East. I can look back on 45 years of collecting. I have turned my hobby of collecting rare and esoteric artefacts into a serious vocation. You can expect not only Eastern art, Saudi culture, Islamic art, the natural history of the Arabian Peninsula and the archive gallery, but much more. Enjoy the exhibition, my son will accompany you'.

The exhibition in rooms over several floors, grouped around a huge, covered hall, is organised by theme. What you see in a display case in other private museums takes up an entire room. An impressive collection of vintage cars - from VW Beetles to Rolls Royces - can be found on the first floor, where valuable oriental carpets cover the walls. The centrepiece is a complete, old curtain of the Kaabavery unusual, as such curtains are rarely seen outside Mecca. No less unusual are the entire office of the former King Saud with all the original furniture and King Saud's private limousine.
